**AND AMENDING THE DECISION 10/2007/GB**

CEPOL – Amending the remit of the Sub-group Survey on European Police Education and Bologna

THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL) <sup>(1)</sup>, and in particular Articles 5 and 6 thereof;

Having regard to the second progress report of the Sub-Group “Survey on European Police Education and Bologna” (SEPEB) <sup>(2)</sup>;

Having regard to the proposal of the Training and Research Committee, submitted by Germany<sup>3</sup>;

Whereas:

- (1) Due to technical delays it has not been possible to follow the timeline as stipulated in Decision 06/2009/GB.
- (2) Therefore the dates as stipulated in decision 06/2009/GB need to be adapted.
- (3) To safeguard a useful result of the survey it has been found that a third face-to-face meeting of the SEPEB Sub-group will be needed.
- (4) Sufficient funds for a third meeting are available from budget line 321 Research and Good Practice.
- (5) It is therefore desirable to amend Decision 06/2009/GB of the Governing Board of the European Police College accordingly.

HAS ADOPTED THIS DECISION:

*Article 1*

Decision 06/2009/GB of the Governing Board of the European Police College establishing a Sub-group “Survey on European Police Education and Bologna”; approving the appointment of three members of the External Relations Working Group: approving the appointment of the chair, deputy chair and four members of the Working Group on Learning; disbanding the Electronic Network Working Group and the Electronic Platform Sub-group; disbanding the project Group “Development of a Concept for Consolidating, Updating and Publishing SEPE” and amending decision 10/2007/GB of the Governing Board of the European Police College <sup>(4)</sup> is amended as follows:

CEPOL – Amending the remit of the Sub-group Survey on European Police Education and Bologna

1. After “Whereas” (on p. 2), the sentence on p. 3, item (2), third paragraph “the final report should be presented to the Governing Board at their 18th meeting” should be changed into the final report should be presented to the Governing Board at their 20th meeting.
2. In Annex 1, p. 3 under the headline “Number of meetings, the sentence “The sub-group shall have no more than two ordinary meetings.” Is changed into “The sub-group shall have no more than three ordinary meetings.”

This Decision shall take effect on the day following that of its adoption.
