EDUCATION AND BOLOGNA" (AMENDING DECISION 10/2007/GB)**

THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL) ⁽¹⁾, and in particular Articles 5 and 6 thereof;

Having regard to the decision of the Governing Board, establishing a Sub-Group "Survey on European Police Education and Bologna" (SEPEB) ⁽²⁾;

Having regard to Decision 10/2007/GB of the Governing Board of the European Police College establishing committees, working groups, project groups and subgroups and laying down rules governing the creation of committees and groups ⁽³⁾, and in particular Article 2 thereof;

Having regard to Decision 04/2010 GB, amending the remit of the Sub-Group, "Survey on European Police Education and Bologna" ⁽⁴⁾;

Having regard to the proposal of the Training and Research Committee, presented by Germany ⁽⁵⁾;

Having regard to the advise of the Strategy Committee ⁽⁶⁾;

WHEREAS:

(1) The Governing Board has tasked the Sub-group "Survey of European Police Education and Bologna" (SEPEB), assigned to the Research and Science Working Group (RSWG) to draw-up a report on the situation of education and training programmes in the field of police and policing, which are open to foreign police officers and especially on the implementation of the Bologna process at national police training institutes in the Member States and at relevant cooperation partners;

(2) The report, composed of the results of the survey and of conclusions, should be transmitted through the Research and Science Working Group to the Training and Research Committee and subsequently to the Governing Board;

(3) The sub-group shall be disbanded when the Governing Board has taken note of the final report;

Article 3


