THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL) and repealing Decision 2000/820/JHA⁽¹⁾, and in particular Article 10(10) thereof;

Whereas:

In accordance with Council Decision 2005/681/JHA and Decision 13/2012/GB², it is for the Governing Board to establish a working group,

HAS ADOPTED THIS DECISION:

Article 1

The Working Group on the Implementation and Evaluation of CEPOL Research and Science Activities for Knowledge Transfer³ is hereby closed ahead of its planned duration in accordance with the Decision 13/2012/GB Art I.V agreed by the Governing Board.

Selected outstanding tasks will be transferred to the newly created Working Group on the Implementation and Evaluation of Research and Science Activities Supported by CEPOL⁴.

Decision 42/2012/GB is amended accordingly.

Article 2

The Working Group for the Planning, Programming, Training Needs Analysis and Budgeting⁵ is hereby extended in accordance with the Decision 13/2012/GB Art I.V agreed by the Governing Board.

The mandate of the Working Group shall be extended until 30 June 2014. The budget of the Working Group for 2014 shall be €9,300. The expected results and the composition of experts shall remain unchanged.

Decision 37/2012/GB is amended accordingly.
