THE STEERING BOARD OF EUROPEAN JOINT MASTER PROGRAMME [EJMP]

HAVING REGARD to the Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL)¹;

HAVING REGARD to the decision of the 32nd CEPOL Governing Board, 11-12 November 2014 Rome, Italy, approving the EJMP and mandating the Director to sign the Framework Partnership Agreement.

HAVING REGARD to the Framework Partnership Agreement signed on the 9th of December 2014 by the CEPOL Director and the Consortium Partners from Bulgaria, Finland, France, Germany, Hungary, Italy, Lithuania, Netherlands, Portugal, Romania, Slovenia and Spain.


HAS DECIDED AS FOLLOWS:

Article 1 – Implementation of the EJMP 2015 – 2017

- 1) The Diploma awarding University will be The National Distance Education University UNED in Spain.
- 2) The Consortium Leader will be Deutsche Hochschule der Polizei, Germany.
- 3) Module I; GENERAL INTRODUCTION AND METHODOLOGY will be implemented by Hungary. Supporting Partners Finland, Frontex, Italy, Netherlands and Slovenia,
- 4) Module II; INTERNATIONAL AND COMPARATIVE POLICING will be implemented by Finland. Supporting Partners; Hungary, Italy, Lithuania Romania and Slovenia,
- 5) Module III; GOVERNANCE AND STRATEGIC ASPECTS OF INTERNATIONAL POLICE COOPERATION will be implemented by Spain. Supporting Partners; Europol, Hungary and Portugal
- 6) Module IV; LEGAL AND REGULATORY ASPECTS OF EUROPEAN POLICE COOPERATION will be implemented by France. Supporting Partners; Europol, Germany and Lithuania.
- 7) Module V; OPERATIONAL ASPECTS OF EUROPEAN POLICE COOPERATION will be implemented by Bulgaria. Supporting Partners; Europol, Lithuania, Netherlands, Portugal and Spain.
- 8) Module VI; MANAGEMENT AND LEADERSHIP ASPECTS OF EUROPEAN POLICE COOPERATION will be implemented by Germany. Supporting Partners; Finland, Italy, Netherlands and Slovenia.
- 9) Module VII; MASTER THESIS will be implemented by Portugal. Supporting Partners; Finland, Slovenia and Spain.
