

DECISION 27/2007/GB  
OF THE GOVERNING BOARD OF THE EUROPEAN POLICE COLLEGE  
**CONCERNING THE WORKING GROUP**  
**“ANALYSIS OF CEPOL’S TRAINING ACTIVITIES”**

Adopted by the Governing Board  
on 27 November 2007

THE GOVERNING BOARD,

Having regard to the Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL) <sup>(1)</sup> and in particular Article 10(10) thereof;

Having regard to Decision 10/2007/GB of the Governing Board of the European Police College establishing Committees, Working Groups, Project Groups and Sub-groups and laying down rules governing the creation of Committees and Groups <sup>(2)</sup>, and in particular Articles 2(2) and 6a(1) thereof;

Having regard to the proposal of the Annual Programme Committee, submitted by France <sup>(3)</sup>;

Whereas:

- (1) Françoise DUEZ (Belgium) has stepped down as chair and member and Guillaume BOULEAU (France) has stepped down as member of the Working Group “Analysis of CEPOL’s Training Activities” and a call for nominating replacement members should be launched.
- (2) According to Article 6a(1) of Decision 10/2007/GB of the Governing Board of the European Police College deputy chairs of Working Groups shall succeed the chairs. Therefore Ken PETERSSON (Sweden) is new chair of the Working Group “Analysis of CEPOL’s Training Activities”.
- (3) Based on the request of the Working Group the Annual Programme Committee sees the need to increase the number of the Working Group’s members by one member.
- (4) It is therefore desirable to change Decision 10/2007/GB of the Governing Board of the European Police College accordingly and to launch a call for nomination for three experts.

HAS ADOPTED THIS DECISION:

*Article 1*

Annex A3.B1 of Decision 10/2007/GB of the Governing Board of the European Police College is replaced by the text in the Annex to this Decision.

**Purpose:**

The ACTA group shall make proposals and recommendations to the Annual Programme Committee (APC) regarding the increase of attendance to CEPOL activities and the evaluation reports of courses and seminars.

**Objectives:**

The ACTA group shall provide the APC with support, advice and the information necessary for the preparation of the Work Programme and the improvement of attendance to CEPOL activities.

**Tasks:**

The ACTA group shall, in particular

1. identify all factors conducive to a better attendance to CEPOL activities;
2. set out all difficulties encountered and propose solutions;
3. if necessary, elaborate audits on existing courses and seminars to improve CEPOL's image and quality;
4. analyse the Evaluation and Assessment Reports of CEPOL activities;
5. report on the findings to the Governing Board.

**Number of meetings:**

The ACTA group shall have no more than four ordinary meetings per year."
