OF THE GOVERNING BOARD OF THE EUROPEAN POLICE COLLEGE  
**AMENDING GOVERNING BOARD DECISION 31/2009 CONCERNING THE  
ADMINISTRATION OF THE E-NET**

Adopted by the Governing Board  
on 9 December 2010

CEPOL - Amending governing board decision 31/2009 concerning the administration of the E-net

THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL) <sup>(1)</sup>, and in particular Article 7(h) thereof;

Having regard to the proposal of the Training and Research Committee <sup>(2)</sup>, submitted by Germany;

Having regard to the opinion of the Strategy Committee <sup>(3)</sup>;

Whereas:

- (1) according to Article 7(h) of Council Decision 2005/681/JHA one of CEPOL's tasks is to develop an electronic network to provide back-up for CEPOL in the performance of its duties, ensuring that the necessary security measures are in place;
- (2) the functionalities of the e-Net are foreseen to offer Platforms for 'Communities of Practice', such as the ones for SIRENE operators & Police English Language Teachers, 'Project-Spaces' for projects such as in the fields of police-research where CEPOL is providing the e-Net functionalities as an "associated partner" or the development of e-learning modules;
- (3) partners of Europol, Frontex, Eurojust and other agencies with whom CEPOL formally has reached cooperation agreements, and who are not eligible for basic user rights such as the academic users, are recognised as legitimate third party users;
- (4) the Secretariat will take procedural and technical care that users not eligible for basic user rights (i.e. "academic and third party users"), will have only access to those areas of e-Net they are assigned to and enrolled in, based on their activity-role;
- (4) it is therefore desirable to amend Article 6 (*User Rights Roles*) of GB Decision 31/2009 regulating the administration of the e-Net.

CEPOL - Amending governing board decision 31/2009 concerning the administration of the E-net

HAS ADOPTED THIS DECISION:

*Article 6*

*User Rights and Roles*

1. The rights and roles as referred to in Article 4(2) of this Decision shall be *basic* user rights, *academic/third party* user rights and *special* user roles.
2. Granting rights and roles shall require prior registration of the user.
3. Basic user rights shall
  - (a) be granted to police officers and employees of police authorities and organisations;
  - (b) allow access to the restricted areas of CEPOL's website
4. Academic user rights shall or can
  - (a) be granted to persons not eligible for basic user rights but are either participants of CEPOL activities or have a professional stake in scientific police research,
  - (b) therefore be allowed access to the e-Library.
  - (c) be allowed access to 'Platforms for Communities of Practice', 'Project-Spaces', specific courses and e-learning modules on the Learning Management System where there is a specific and appropriate need.
5. Third-party user rights shall or can
  - (a) be granted to persons not eligible for basic user rights but are non-academic partners in CEPOL activities
  - (b) therefore be allowed access to 'Platforms for Communities of Practice', 'Project Spaces', 'courses' and 'e-learning modules' on the Learning Management System where there is a specific and appropriate need.
  - (c) be allowed access to the e-Library where there is a specific and appropriate need.
6. Special user roles, which, notwithstanding the criteria as laid down in subparagraph 3(a) of this article, shall include basic user rights, shall be
  - (a) Member of the Governing Board, a Committee, Working Group, Project Group, Sub-group;
  - (b) Moderator of closed forum and chat;
  - (c) Participant in CEPOL activities, trainers and experts as well as other roles related to the LMS/e-Learning tool.
  - (d) Submitter, Moderator, Authority, Collection Administrator for collections within the e-Library.
