

Decision of the Management Board 04/2021/MB

**ON AMENDING DECISION 02/2021/MB ON THE CEPOL SINGLE
PROGRAMMING DOCUMENT 2021-2023**

Adopted by the Management Board

on 18 May 2021

THE MANAGEMENT BOARD,

Having regard to Regulation (EU) 2015/2219 of the European Parliament and of the Council of 25 November 2015 on the European Union Agency for Law Enforcement Training (CEPOL) and replacing and repealing Council Decision 2005/681/JHA¹, and in particular Articles 9(1) and 10 thereof,

Having regard to amending Decision 02/2021/MB on CEPOL Single Programming Document 2021-2023 and its annex, adopted on 15 March 2021,

Having regard to Decision 29/2020/MB on the CEPOL Single Programming Document 2021-2023 and its annex, adopted on 12 November 2020,

Having regard to Decision 13/2019/MB on the CEPOL Financial Regulation and repealing Decision 01/2014/GB, adopted on 22 May 2019,

Having regard to Decision 07/2021/DIR of the Executive Director on awarding of grants for the implementation of CEPOL granted training activities in 2021, adopted on 09 February 2021,

Whereas:

- (1) On 2 March 2021, a Framework Partner notified CEPOL that they withdraw from the implementation of the granted activity 62/2021: “Instruments and Systems of European Police Cooperation in English” due to Covid-19 situation;
- (2) Commission’s comments on the annual work programme for 2021 of CEPOL were received on 15 March 2021;
- (3) Two new procurement procedures were added to the global budgetary envelope reserved for operational procurements for new procedures;
- (4) Additional amounts need to be indicated in the global budgetary envelope reserved for operational procurements to be implemented under the 2021 budget to account additional services;
- (5) Therefore, there is a need to amend Sections III, IV.I, IV.II of Single Programming Document 2021-2023 to reflect the withdrawal and Commission’s comments. There is also a need to amend Annexes III, XI.a and XIII to reflect the changes in respective envelope.

HAS ADOPTED THIS DECISION:

Article 1

CEPOL shall amend the following sections of the Single Programming Document 2021-2023:

- a. Section III – Work Programme 2021
 - i. Goal 2: CEPOL will further develop, support and implement training activities [...]
- b. Section IV.I – 2021: CEPOL residential activities
- c. Section IV.II – Grant Agreements
- d. Annex III: Financial Resources 2021-2023
- e. Annex XI.a: Global budgetary envelope reserved for operational procurements
- f. Annex XIII: Budget Correspondence table

Article 2

The amendments to the Single Programming Document 2021-2023 as annexed to the present Decision are hereby adopted.

The present Decision shall take effect the day of its adoption.
