



**Decision of the Management Board 07/2022/MB**

**ON THE APPOINTMENT OF A REPORTING PANEL FOR COMPLETING  
THE PROBATIONARY PERIOD ASSESSMENT OF THE EXECUTIVE  
DIRECTOR OF CEPOL**

## THE MANAGEMENT BOARD,

Having regard to Regulation (EU) 2015/2219 of the European Parliament and of the Council of 25 November 2015 establishing the European Union Agency for Law Enforcement Training (CEPOL) and replacing and repealing Council Decision 2005/681/JHA<sup>1</sup>, and in particular Articles 9(t) and 23(6) thereof,

Having regard to the Staff Regulations of Officials of the European Union ('Staff Regulations') and the Conditions of Employment of Other Servants of the European Union ('CEOS'), laid down by Regulation (EEC, Euratom, ECSC) No 259/68 of the Council<sup>2</sup>, and in particular Article 14 of the CEOS,

Having regard to the draft Decision of the Governing Board on the appraisal and probationary period of the Director - made during its 19<sup>th</sup> GB meeting of 23-24 February 2010, held in Madrid, Spain - as submitted to the Commission on 25 May 2010 and approved by the Commission on 24 September 2010, and in particular Article 3 thereof,

Having regard to MB Decision 16/2018/MB on the appointment of a Reporting Panel for completing the probationary period assessment of the Executive Director of CEPOL, and in particular paragraph (3) thereof,

### Whereas:

- (1) According to the applicable rules, the assessment of the fulfilment of the job objectives which have been agreed for the duration of the probation period of the Executive Director, is to be carried out by a Panel.
- (2) The Panel is to be composed of three members. One member is the representative of the European Commission and the remaining two members are to be designated from among the members of the Management Board.
- (3) The remaining two members of the Reporting Panel are to be appointed by the Management Board on the basis of the current and incoming TRIO presidency countries.
