Having regard to Regulation (EU) 2015/2219 of the European Parliament and of the Council of 25 November 2015 on the European Union Agency for Law Enforcement Training (CEPOL) and replacing and repealing Council Decision 2005/681/JHA<sup>1</sup> (hereinafter 'CEPOL Regulation'), and in particular Article 9(1)(a), Article 10(1) and Article 14(d) thereof,

Having regard to the Management Board decision 06/2016/MB Adopting the Single Programming Document 2017-2019, and in particular the List of Residential activities, p.38, which includes a joint activity with EMCDDA on Strategic Analysis in the context of the fight against Drug Crime.

Having Regard to the priorities set out in the Council Conclusion on the European Policy Cycle<sup>2</sup>.

Whereas EMCDDA has requested CEPOL to develop Common Curriculum on strategic analysis of drug markets and has provided its content.

Whereas it is for the Management Board on the basis of Article 9(1)(s) of CEPOL Regulation to adopt Common Curricula.

HAS ADOPTED the Common Curriculum on Drug Markets and Drug-related crime – Strategic Analysis as detailed in the Annex to this Decision.
