

Decision of the Management Board 29/2021/MB

**ON THE VOTING FOR THE APPOINTMENT OF THE EXECUTIVE
DIRECTOR OF CEPOL**

Adopted by the Management Board

on 16 December 2021

THE MANAGEMENT BOARD,

Having regard to Regulation (EU) 2015/2219 of the European Parliament and of the Council of 25 November 2015 establishing the European Union Agency for Law Enforcement Training (CEPOL) and replacing and repealing Council Decision 2005/681/JHA¹, and in particular Article 23 thereof,

Having regard to Regulation No 31 (EEC), 11 (EAEC), laying down the Staff Regulations of Officials and the Conditions of Employment of Other Servants (CEOS) of the European Economic Community and the European Atomic Energy Community², and in particular Articles 2(a) and 12(2) of CEOS,

Having regard to the Decision of the Management Board 07/2017/MB laying down rules on the selection and the appointment of the Executive Director of CEPOL, and in particular Articles 4 and 5 thereof,

Having regard to the vacancy notice for the Executive Director of CEPOL (Grade AD 14)³ published by the European Commission,

Whereas:

- (1) The vacancy notice for the position of the Executive Director of CEPOL was published in the Official Journal of the European Union on 25 August 2021 with a deadline for applications of 06 October 2021.
- (2) The Selection Committee appointed by the Management Board on 09 June 2021 (14/2021/MB), shortlisted 6 applicants possessing the best profile for the specific requirements of the post.
- (3) Out of the 6 shortlisted candidates, 1 withdrew its application. The remaining 5 candidates have been scheduled to be tested online by an assessment centre (organised by CEPOL and an external consultant) between 22 and 24 November.
- (4) The above mentioned 5 candidates were subsequently interviewed by the Selection Committee on 02 December 2021.
- (5) On the basis of the results of the interviews, and taking into consideration the results of the assessment centre, the Selection Committee drew up a list of 3 candidates.
- (6) The 3 candidates were invited for an interview with the Management Board in the context of an extraordinary Management Board meeting that took place on 16 December 2021.

Ms Maria Montserrat MARIN LOPEZ is appointed as Executive Director of CEPOL. The term of office shall start on 16 February 2022.

Article 2

This Decision shall take effect on 16 February 2022.
