The purpose of this procurement procedure is to increase the ceiling of framework service contract CEPOL/FWC/2018/280 for the provision of services to support CEPOL Project Activities in the Western Balkans. According to the decision of the contracting authority duration of Financial Investigation In-Service Trainig Programme Western Balkan (2017-2019) project has been extended until 31.3.2020 and therefore additional activities will be organized in WB region (Albania, Bosnia and Herzegovina, Republic of North Macedonia, Kosovo*, Montenegro, Serbia). In order to continue with the successful organization of project activities and to cover for the services to be provided until the end of the project, the ceiling of the contract needs to be increased.

Explanation:

CEPOL signed on 13.11.2018 framework service contract CEPOL/FWC/2018/280 for the provision of services to support project activities in WB. The contract was awarded following the open procurement procedure CEPOL/PR/OP/2018/003. The contract was initially signed with a duration from the date on which the last party signed it until 31.12.2019 with the possibility of automatic renewal up to 1 time, for a period of 6 months. The maximum value of the contract over the total possible duration was set at 240 000 EUR.

— the contract included an option to increase the maximum contract volume via a negotiated procedure with the successful tenderer in accordance with Art. 134 (1) (e) of Commission Delegated Regulation (EU) No 1268/2012 (the Rules of Application). The above mentioned commission delegated regulation was repealed by Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18.7.2018 on the financial rules applicable to the general budget of the Union (the 'Financial Regulation' or 'FR'). Further to this, the applicable legal basis for the use of the above mentioned option is now Point 11.1 (e) Annex 1 FR, — the possibility to use the option to increase the maximum contract volume as described above was explicitly stated in the tender specifications,

— the initial value of the contract was set at 240 000 EUR (ceiling of the framework contract).

According to the decision of the contracting authority duration of Financial Investigation In-Service Trainig Programme Western Balkan (2017-2019) project has been extended until 31.3.2020 and therefore additional activities will be organized in WB region. In order to meet the business needs of project activities in the Western Balkans the ceiling of the contract needs to be increased by 105 000,00 EUR.
