	"Where an e-journal or access to back issues is not offered, the tenderer shall state in the corresponding cell "no offer"						
	"Where an e-journal or access to back issues is offered free of charge, the tenderer shall state in the corresponding cell "0.00".  If we get it right, "NO OFFER" or "0" would mean 0 points at evaluation.						
	Therefore, we find Criterion No.2 a bit problematic.						
	Not all publishers are offering backfiles (back copy volumes) for single journals, so we do believe during evaluation you should differentiate between "NO OFFER" because an Agency does not want to give an offer and "NO OFFER" because of reasons beyond our competence (rooting in publishers' policy).
