# DECISION 20/2007/GB OF THE GOVERNING BOARD OF THE EUROPEAN POLICE COLLEGE MODIFYING THE ESTABLISHMENT PLAN 2007

Adopted by the Governing Board in a written procedure on 1 September 2007

#### THE GOVERNING BOARD,

Having regard to Decision 22/2006/GB of the Governing Board of the European Police College adopting the Financial Regulation (1), and in particular Article 32(1) thereof;

Having regard to Decision 34/2006/GB of the Governing Board of the European Police College adopting the budget for the financial year 2007 (2);

Having regard to the proposal of the Director of the European Police College (hereinafter referred to as "CEPOL");

#### Whereas:

- (1) It has become apparent that the grading of the post of CEPOL's Accounting Officer in AST 3 does not fully meet the responsibilities assigned to this function and is not fully in line with CEPOL's general policy on grading posts (3). The grading should therefore be changed to AD5.
- (2) Mark HALL, appointed by the Governing Board as Accounting Officer on 31 August 2006 (4) has resigned from his duties and the appointment of a succeeding Accounting Officer is pending the recruitment and selection of a suitable candidate. In order to offer more appropriate conditions as soon as possible the grading of the post of the Accounting Officer should be changed before the recruitment starts.
- (3) No post in AD5 of the establishment plan is unassigned to any function. As the recruitment of the succeeding Accounting Officer should start as soon as possible the Governing Board should use its authority for modifying the establishment plan in accordance with Article 32(1) of Decision 22/2006/GB.
- (4) The modification to the establishment plan does not lead to an increase of the total number of posts of the establishment plan 2007 and does not lead to raised financial requirements in Title 1 of the Budget 2007.

#### HAS ADOPTED THIS DECISION:

#### Article 1

The establishment plan is modified as detailed in the Annex to this Decision.
