

DECISION 22/2007/GB

OF THE GOVERNING BOARD OF THE EUROPEAN POLICE COLLEGE

**AMENDING THE RULES FOR THE REIMBURSEMENT OF EXPENDITURE FOR
ORGANISING MEETINGS OF COMMITTEES**

Adopted by the Governing Board
on 26 September 2007

THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA ⁽¹⁾, and in particular Article 10(10) thereof;

Having regard to the proposal from the Budget and Administration Committee, submitted by the Portuguese Presidency of the European Police College ⁽²⁾;

Whereas:

- (1) The reimbursement for organising meetings of Committees does not cover accommodation and meals as this expenditure are covered by the reimbursement for organising meetings of working groups, project groups and sub-groups. In case accommodation and meals are not offered for free by the organiser anyway, costs have to be borne by Member States.
- (2) As there is no obvious reason to treat the reimbursement for organising Committees and the reimbursement for organising other groups in different ways, the reimbursement for organising meetings of Committees should cover accommodation and meals as well.
- (3) Decision 8/2007/GB of the Governing Board of the European Police College laying down Rules Governing the Organisation of Meetings and the Reimbursement of Expenditure for Attending and Organising Meetings of the Governing Board, Committees, Working Groups, Project Groups, Ad Hoc Working Groups and Sub Groups and Hand-over Meetings ⁽³⁾ should therefore be amended accordingly.

HAS ADOPTED THIS DECISION:

Article 1
Amendment

Decision 8/2007/GB of the Governing Board of the European Police College laying down Rules Governing the Organisation of Meetings and the Reimbursement of Expenditure for Attending and Organising Meetings of the Governing Board, Committees, Working Groups, Project Groups, Ad Hoc Working Groups and Sub Groups and Hand-over Meetings ⁽³⁾ is amended as follows:

1. Article 14 is amended as follows:

(a) In the heading the words “and Committees” are deleted.

(b) Paragraph (1)(c) is deleted.

(c) In paragraph (3) the words “or of chairs of the Committees” are deleted.

2. Article 15 is amended as follows:

(a) At the beginning of the heading the word “Committees,” is inserted.

(b) In paragraphs (1), (2) and (3) the words “6 and” are replaced by the words “5 to”.

(c) In paragraph (3) after the words “meeting of the” the word “Committee,” is inserted.
