## THE GOVERNING BOARD,

Having regard to Decision 29/2006/GB of the Governing Board of the European Police College laying down the Common Curriculum Policy (1), and in particular No 4.3.2 thereof;

Having regard to the proposal of the Director;

### Whereas:

- (1) It is for the Governing Board on the basis of Decision 29/2006/GB of the Governing Board of the European Police College to appoint a module advisor on a proposal of the Director for each Common Curriculum.
- (2) Following the call for nominations twelve experts were nominated by eight Member States (Czech Republic, Germany, Greece, Spain, Italy, Hungary, Netherlands, Portugal). The selection was done on the basis of the submitted curriculum vitae, which were analysed against the required features and competencies in accordance with No 4.3.2 of Decision 29/2006/GB of the Governing Board of the European Police College.
- (3) It is appropriate Eduardo BOROBIO LEON (Spain) is appointed module advisor for the Common Curriculum "Counter Terrorism", who has experience on the level of Counter-Terrorism, in police training as well as in coordinating and organising courses in cooperation with other countries and therefore a basic understanding of training issues in other countries; he also has a high level of knowledge of the English language.
- (4) It is appropriate Evangelos STERGIOULIS (Greece) is appointed module advisor for the Common Curriculum "Europol", who has a longstanding experience on the level of Europol and cooperation between Europol and the Member States, and therefore a good network of connections within Europol as well as understanding of the needs of the Member States with regards to Europol; he also has teaching experience at several police training institutions, and therefore he has a basic understanding of the training needs of the Member States with regards to Europol; furthermore he was involved in the development of the Common Curriculum "Europol" in 2005.
- (5) It is appropriate Greta ELSINGA (Netherlands) is appointed module advisor for the Common Curriculum "Police Ethics and Prevention of Corruption", who has a high expertise on the issues of Police Ethics and Prevention of Corruption on a European level as a researcher and adviser to the Council of Europe on these issues; furthermore she is a trainer and was involved in the

development and implementation of this Common Curriculum; she also has a good knowledge on the problems and requirements of the Common Curriculum and its national implementation and she has a high level of knowledge of the English language.

- (6) It is appropriate Detlef SCHRÖDER (Germany) is appointed module advisor for the Common Curriculum "Domestic Violence", who has a high level of experience in the field of Domestic Violence and a lot of experience in the field of training on this issue; he has a basic understanding of the needs for training of the Member States in this field; furthermore he has a good knowledge on the problems and requirements of this Common Curriculum as the chair of the related Sub-group and he has a high level of knowledge of the English language.
- (7) It is appropriate Mariana RAIMUNDO (Portugal) is appointed module advisor for the Common Curriculum "Money Laundering", who has a high level of experience both in the field of Money Laundering and Financial Crime and a lot of experience in the field of training on this issue; furthermore she has a basic understanding of the needs for training of the Member States in this field; as the chair of the related Sub-group she has a good knowledge on the problems and requirements of this Common Curriculum and she has a high level of knowledge of the English language.
- (8) It is appropriate Giuseppe BATAGLIA (Italy) is appointed module advisor for the Common Curriculum "Trafficking in Human Beings", who has a wide range of experience in the field of Trafficking in Human Beings as a police officer; he has been active as a researcher and has a vast knowledge of the matter; furthermore he has experience as a trainer and has a basic understanding of the needs of the Member States regarding training on Trafficking in Human Beings; he has a high level of knowledge of the English language.
- (9) A service agreement will be concluded between the Director and the national police training institute, which employs the module advisor. In accordance with No 4.3.2 of Decision 29/2006/GB of the Governing Board of the European Police College the conditions will be based on the following:

#### Tasks:

- a) further development and permanent updating of the Common Curricula;
- b) provide content support and support on the level of training methods to the Member States when planning and implementing the Common Curricula within the National Training system:
- c) deal with enquiries coming from Member States or the CEPOL Secretariat:
- d) be in contact with and report to the CEPOL Secretariat for follow-up and feedback;
- e) be a source for Member States and the Common Curricula Coordination Working Group about further developments on the topic of the Common Curriculum:

- f) provide solutions for problems which may be encountered in Member States' implementation;
- g) attend the meetings of the Common Curricula Coordination Working Group and other meetings requested by the CEPOL Secretariat;
- h) contribute to the development of material for e-learning modules.
- Fee: 200 €/working day, calculated for five to six working days/month during a period of 12 months from the start of the contract; the contract can be extended.
- In case travel is requested by the CEPOL Secretariat to meetings or for coordination of the work, travel expenditures will be paid in the same way as for the staff of the CEPOL Secretariat.
- Start of the contract: After appointment of the module advisors by the Governing Board, the contracts can become effective as soon as they are signed, preferably in December 2007.

- 4. Detlef SCHRÖDER (Germany) is appointed module advisor for the Common Curriculum "Domestic Violence".
- 5. Mariana RAIMUNDO (Portugal) is appointed module advisor for the Common Curriculum "Money Laundering".
- 6. Giuseppe BATAGLIA (Italy) is appointed module advisor for the Common Curriculum "Trafficking in Human Beings".
