OF THE GOVERNING BOARD OF THE EUROPEAN POLICE COLLEGE  
**ADOPTING CEPOL'S EXTERNAL RELATIONS POLICY**

Adopted by the Governing Board  
on 20 May 2008

THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL) <sup>(1)</sup>, and in particular Article 8 thereof;

Having regard to the proposal of the Strategy Committee <sup>(2)</sup>, submitted by the Slovenian Presidency of the European Police College;

Whereas:

CEPOL should have an External Relations Policy.

HAS ADOPTED the External Relations Policy as detailed in the Annex to this Decision.

### I - LEGAL FRAMEWORK

Article 8 of the Council Decision 2005/681/JHA establishing the European Police College (CEPOL) and repealing decision 2000/820/JHA deals with cooperation with other bodies as follows:

#### **"Cooperation with other bodies**

1. CEPOL may cooperate with relevant bodies of the European Union in the field of law enforcement and other related areas and with relevant training bodies in Europe.
2. CEPOL may cooperate with national training institutes of non-member States of the European Union, in particular with those of the candidate countries, as well as with those of Iceland, Norway and Switzerland.
3. The Governing Board may authorise the Director of CEPOL to negotiate cooperation agreements with any of the bodies mentioned in paragraphs 1 and 2. Such cooperation agreements may be concluded only with the authorisation of the Governing Board. Cooperation agreements with

bodies of non-member States of the European Union can only be concluded after the approval of the Council has been obtained.

4. CEPOL may take into account recommendations made by Europol and/or the Task Force of Chiefs of Police of the Member States of the EU, without prejudice to the rules governing the adoption of the CEPOL work programme."

## **II – RULES OF EXTERNAL RELATIONS**

Requests for cooperation with CEPOL should be addressed to the CEPOL Secretariat which should forward them to the CEPOL Presidency and the Chair of External Relations Working Group (ERWG).

In case the answer to a request does not follow directly from this policy paper, the ERWG should present the request and a proposal thereof to the Strategy Committee; thereafter a decision is taken by the Governing Board.

The CEPOL Presidency representing the Governing Board and the Director are responsible for contacts with relevant EU Institutions (Parliament, Council, and Commission) and the implementation of priorities. There is no need for an agreement.

The external relations of CEPOL (ER) shall be managed as follows:

### **1) European bodies**

- **EU agencies and bodies**

- ✓ **3<sup>rd</sup> pillar Law enforcement agencies: Europol and Eurojust**

In accordance with Article 8 of the Council Decision of 20 September 2005, if the cooperation with EU agencies becomes permanent, an agreement has to be negotiated by the Director of CEPOL.

If the cooperation is not permanent, there may be informal contacts between the Agencies and the secretariat. The Director will report to the CEPOL Presidency and the Chair of ERWG.

- ✓ **1<sup>st</sup> and 2<sup>nd</sup> pillars EU bodies and Agencies**

The same principles apply for the agencies whose tasks may have some bearing on CEPOL's activities, such as the EMCDDA (European Monitoring Centre for Drugs and Drug Addiction), the ETF (European Training Foundation), CEDEFOP (European Centre for the Development of Vocational Training) or FRONTEX (Border Agency).

- **EU networks:**

The EU networks expressing a will to cooperate should contact the Director/Secretariat. The Director will report to the CEPOL Presidency and the Chair of ERWG.

- ✓ **Senior Police Officers training academies of EU Member States**

These academies should address requests of attendance to their CEPOL National Contact Point (NCP). The requests sent directly to the Secretariat, should be forwarded to the NCP, with copy to the CEPOL Presidency and the Chair of ERWG.

- ✓ **European Associations and networks in the field of Police officers training**

Those associations may contact the Director/Secretariat for cooperation. Their requests will be reported to the ERWG for first discussion. If necessary, the ERWG will pass on the request to the Strategy Committee, and final decision will be reached by the Governing Board. They may be involved as observers in CEPOL activities.

The acceptance of European body experts should be included in the commitment forms designed by the secretariat.

## **2) Acceding Countries (ACC)**

Those Countries are invited to one Governing Board meeting per presidency at CEPOL's cost. They can attend, as observers, committee meetings at their own costs (ATOC). They are invited as experts in ERWG meetings (their costs will be reimbursed by CEPOL following the applicable rules). Like Member States, ACC are authorised to send trainees, as well as experts, in CEPOL activities. They may send delegates to conferences. They may also host and organise CEPOL courses and conferences.

The acceptance of Acceding Countries experts should be included in the commitment forms designed by the secretariat.

## **3) Candidate Countries (CC)**

This case refers to Official Candidate Countries. Delegates from ERWG, the CEPOL Presidency and the Secretariat of CEPOL should establish contacts during fact finding missions in these countries; in order to meet National Contact Points appointed by the authorities of the CC. CC are invited in ERWG meetings (ATOC).

Training institutes for senior officers of CC should be involved in CEPOL activities according to the below table, via their National Contact Points. In line with the EU

policy, cooperation agreements should be established between CEPOL and training institutes of CC willing to be part in CEPOL activities.

The acceptance of Candidate Countries experts should be included in the commitment forms designed by the secretariat.

#### **4) Associated Countries (ASC)**

Schengen Member States or Schengen functionalities users are to be placed in this category. They have to sign a cooperation agreement. They participate in CEPOL activities at their own costs (ATOC).

They are invited in Governing Board, committees and ERWG meetings as observers (ATOC). ASC are authorised to send trainees (ATOC), as well as experts, in CEPOL activities. They may send delegates to conferences. They may also host and organise CEPOL courses and conferences.

The acceptance of Associated Countries experts should be included in the commitment forms designed by the secretariat.

#### **5) Potential Candidate Countries (PCC) and ENP Countries (ENP)**

Those countries are mainly covered by specific financial programmes run by the Commission.

CEPOL reaffirms its willingness to cooperate in this regard, using preferably non-CEPOL funds.

If course organisers or a CEPOL group wish to invite trainees or if Potential Candidate Countries and ENP Countries ask to send trainees (ATOC) to CEPOL activities, they should report to the Director who will contact/inform the Chair of the ERWG for advice and the Chair of the Governing Board for decision. Final decisions are communicated to the Governing Board at its next session.

Experts/lecturers have to undergo the same procedure as the one described for trainees in the previous paragraph.

The acceptance of experts from Potential Candidate Countries and ENP Countries should be included in the commitment forms designed by the secretariat.

## **6) All non EU Member States and bodies in non EU Member States (NON-EU)**

Relevant governmental bodies, inter-governmental organisations (IGOs), non governmental organisations (NGOs), universities, non-EU networks, national training institutes of non EU Member States feature in this category.

If the cooperation with non EU Member States/bodies has to become permanent, an agreement should be negotiated by the Director of CEPOL and in full cooperation with the Presidency and the ERWG Chair presented to the Governing Board following the applicable rules.

If the cooperation is not permanent, non EU Member States/bodies should contact the Director. The Director will report that request to the CEPOL Presidency and the Chair of ERWG.

If course organisers or a CEPOL group wish to invite trainees or if NON-EU member States ask to send trainees (ATOC) to CEPOL activities, they should report to the Director who will contact/inform the Chair of the ERWG for advice and the Chair of the Governing Board for decision. Final decisions are communicated to the Governing Board at its next session.

Experts/lecturers have to undergo the same procedure as the one described for trainees in the previous paragraph.

The acceptance of NON-EU experts should be included in the commitment forms designed by the secretariat.

## **7) Private sector**

CEPOL may cooperate with the private sector for training purposes. The acceptance of this cooperation should be included in the commitment forms designed by the secretariat.

The involvement of the private sector should be discussed in the Annual Programme Committee and Strategy Committee.
