OF THE GOVERNING BOARD OF THE EUROPEAN POLICE COLLEGE

APPOINTING MODULE ADVISERS FOR

THE COMMON CURRICULUM “CIVILIAN CRISIS MANAGEMENT” AND

THE COMMON CURRICULUM “MANAGEMENT OF DIVERSITY”

Adopted by the Governing Board
on 25 February 2009

THE GOVERNING BOARD,

Having regard to Decision 29/2006/GB of the Governing Board of the European Police College laying down the Common Curriculum Policy ⁽¹⁾, and in particular No 4.3.2 thereof;

Having regard to the proposal of the Director;

Whereas:

- (1) It is for the Governing Board on the basis of Decision 29/2006/GB of the Governing Board of the European Police College to appoint a module advisor on a proposal of the Director for each Common Curriculum.
- (2) Following the call for nominations six experts were nominated by six Member States (Czech Republic, France, Hungary, Ireland, Latvia and Lithuania) for the Common Curriculum “Civilian Crisis Management” and the Common Curriculum “Management of Diversity”. The proposal is put forward on the basis of the submitted curricula vitae, which were analysed against the required features and competencies in accordance with No 4.3.2 of Decision 29/2006/GB of the Governing Board of the European Police College.
- (3) It is appropriate Arunas TAMASAUSKAS (Lithuania) is appointed Module Advisor for the Common Curriculum “Civilian Crisis Management”, who is a national expert on public security and civilian crisis management; he is also familiar with police training on the subject and has an understanding of the different structures and requirements in the various Member States; his knowledge of the English language is good. The proposed candidate is familiar with the Common Curricula as well as the CEPOL structure and is embedded in the CEPOL network
- (4) It is appropriate Jiří SŮVA (Czech Republic) is appointed Module Advisor for the Common Curriculum “Management of Diversity”, who is a national expert on management of diversity; he also develops training material for police trainers and teachers in the area of human rights and ethics in the context of policing, and organises opportunities for further education of police officers and police teachers and instructors on management of diversity; his knowledge of the English language is excellent. The proposed candidate has a profound understanding of police culture and the requirements of training on this topic in the different Member States.
- (5) A service agreement will be concluded between the Director and the national police training institutes, which employ the Module Advisors. In accordance with

No 4.3.2 of Decision 29/2006/GB of the Governing Board of the European Police College the conditions will be based on the following:

- Tasks:
 - a) further development and permanent updating of the Common Curriculum;
 - b) provide content support and support on the level of training methods to the Member States when planning and implementing the Common Curriculum within the National Training system;
 - c) deal with enquiries coming from Member States or the CEPOL Secretariat;
 - d) be in contact with and report to the CEPOL Secretariat for follow-up and feedback;
 - e) be a source for Member States and the Common Curricula Coordination Working Group about further developments on the topic of the Common Curriculum;
 - f) provide solutions for problems which may be encountered in Member States' implementation;
 - g) attend the meetings of the Common Curricula Coordination Working Group and other meetings requested by the CEPOL Secretariat;
 - h) contribute to the development of material for e-learning modules.
- Fee: 200€/working day, calculated for five to six working days per month during a period of 12 months from the start of the contract; the contract can be extended.
- In case travel is requested by the CEPOL Secretariat to meetings or for coordination of the work, travel expenditures will be paid in the same way as for the staff of the CEPOL Secretariat.
- Start of the contract: After appointment of the Module Advisors by the Governing Board, the contract can become effective as soon as it is signed.

HAS ADOPTED THIS DECISION:

*Article 1
Appointments*

1. Arunas TAMASAUSKAS (Lithuania) is appointed Module Advisor for the Common Curriculum "Civilian Crisis Management".
2. Jiří SŮVA (Czech Republic) is appointed as the Module Advisor for the Common Curriculum "Management of Diversity".

*Article 2
Entry into force*

This decision shall take effect on the day following that of its adoption.
