THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL) ⁽¹⁾, and in particular Articles 5, 6 and 10(10) thereof;

Having regard to Decision 10/2007/GB of the Governing Board of the European Police College establishing committees, working groups, project groups and sub-groups and laying down rules governing the creation of committees and groups ⁽²⁾, and in particular Articles 2 and 6 thereof;

Having regard to the report of the Project Group “Development of a Concept for Consolidating, Updating and Publishing SEPE” (PGDCSEPE) ⁽³⁾;

Having regard to the proposal of the Strategy Committee, submitted by the Czech Presidency of the European Police College ⁽⁴⁾;

Having regard to the proposals of the Training and Research Committee, submitted by Germany ⁽⁵⁾;

Whereas:

- (1) It is for the Governing Board on the basis of Decision 10/2007/GB to establish sub-groups, to approve the appointment by Committees of chairs, deputy chairs and members of Working Groups and to disband working groups, project groups and sub-groups.
- (2) The systematic collection, analysis, evaluation and presentation of information about education programmes in the field of police and policing open to foreign police officers and about the implementation of the Bologna process in national police training institutes in Member States and in relevant cooperation partners is an excellent basis for the development of possibilities for the participation in police training in other countries.

For the development of a questionnaire and implementation of a survey, for a systematic analysis and evaluation of the answers and for the presentation of the results a sub-group should be established.

The Governing Board should be informed by the Training and Research Committee about the appointment of chair and members of the sub-group at their 16th meeting; the final report should be presented to the Governing Board at their 18th meeting.

The total budgetary demands for implementing this decision to be allocated from CEPOL’s budget are estimated at EUR 6 000.

The Governing Board may decide at a later stage further steps for exploring the police training situation in the Member States and in relevant cooperation partners.

- (3) One membership position in the External Relations Working Group has been vacant. Subsequently a call for nominating experts was launched and one expert was appointed member of the External Relations Working Group by the Strategy Committee.

In order to widen the perspective of the Working Group’s activities the Strategy Committee desires to increase the number of members of the Working Group by two members and has appointed two additional experts from other Member States.

It is appropriate the appointment of Eduardo BOROBIO LEON (Spain), Wolfgang HÄSEKER (Germany) and Ramon LOIK (Estonia) as members of the External Relations Working Group is approved.

- (4) Marianne HILTON (Sweden), who was appointed deputy chair of the Working Group on Learning, Myrianthis IORDANOU (Cyprus), Petri RAIVOLA (Finland) and Jan VYKOUKAL (Czech Republic) are no longer available as members of the Working Group on Learning. Subsequently a call for nominating experts was launched and four experts were appointed members of the Working Group on Learning by the Training and Research Committee; additionally the Training and Research Committee has appointed one of the members of the Working Group on Learning as new deputy chair.

Sandra WIJKHUIJS (Netherlands) has stepped down as chair of the Working Group on Learning; the Training and Research Committee has therefore appointed one of the members of the Working Group on Learning as new chair.

It is appropriate the appointment of Nevenka TOMOVIČ as chair of the Working Group on Learning, the appointment of Marek LINK (Estonia) as deputy chair of the Working Group on Learning and the appointment of Joseph CARTON (Ireland), David l’ANSON (United Kingdom), Zsolt

MOLNÁR (Hungary) and Walentyna TRZCINSKA (Poland) as members of the Working Group on Learning, who fulfil the defined profile, is approved.

- (5) Following the recruitment of ICT expertise to the CEPOL Secretariat a technical advice and support group with exclusively transversal tasks is no longer required; subsequently the Electronic Network Working Group should be disbanded. The remaining working groups would take into account the aspects in their work as appropriate.

Subsequently the Electronic Platform Sub-group, which is assigned to the Electronic Network Working Group, should be disbanded as well.

- (6) In accordance with the remit of the Project Group “Development of a concept for consolidating, updating and publishing SEPE” ⁽¹⁾ the Project Group shall be closed when the Training and Research Committee has taken note of the final report.

The final report of the Project Group “Development of a concept for consolidating, updating and publishing SEPE” was tabled to the 11th meeting of the Training and Research Committee ⁽²⁾.

- (7) It is therefore desirable to amend Decision 10/2007/GB of the Governing Board of the European Police College accordingly.

HAS ADOPTED THIS DECISION:

Article 1

1. The Governing Board establish the Sub-group “Survey on European Police Education and Bologna”.
2. In Decision 10/2007/GB of the Governing Board of the European Police College establishing committees, working groups, project groups and sub-groups and laying down rules governing the creation of committees and groups ⁽³⁾ Annex A4.B4.D1 is added as detailed in Annex 1 to this decision.

By mutual agreement the chairs of the above mentioned working groups shall appoint in writing to the CEPOL Secretariat a representative and an alternate representative of their working group. In case neither the representative nor the alternate representative is able to attend a meeting, the chairs of the working groups shall appoint in writing to the CEPOL Secretariat a substitute for that meeting.

The Association of European Police Colleges (AEPC) shall be invited by the chair of the sub-group to send a representative to the meetings of the sub-group on their own cost.

Purpose:

Purpose of the sub-group is to provide an overview of education and training programmes in the field of police and policing, which are open to foreign police officers and especially of the implementation of the Bologna process at national police training institutes in the Member States and at relevant cooperation partners for the period until the end of 2009. The outcome shall be a basis for bringing together national police training institutes in the Member States and relevant cooperation partners by developing possibilities for the participation in police training in other countries.

Objectives:

The sub-group shall draw-up a report on the situation of education and training programmes in the field of police and policing, which are open to foreign police officers and especially on the implementation of the Bologna process at national police training institutes in the Member States and at relevant cooperation partners.

Tasks:

The Sub-group shall

1. establish an online survey on the situation of education and training programmes in the field of police and policing in national police training institutes in the Member States and in relevant cooperation partners, which are open to non-national Police officers; by developing and distributing a questionnaire the sub-group shall in particular explore, which of the national police training institutes and of the relevant cooperation partners have introduced Bachelor and/or Master Study Courses in the field of police and policing in accordance with the Bologna process or have planned to establish such courses until the end of 2009, with the following topics:
 - a) title of the programme or course and title of the graduation;
 - b) course structure, main content and delivering type (curriculum/modules; full time, part time – next to the job; correspondence course; residential - blended learning);
 - c) course according to the Bologna criteria (implemented features);
 - d) type of accreditation or validation and accreditation or validation body;
 - e) duration;
 - f) conditions for access (entry requirements);
 - g) language(s);
 - h) cost in Euros; financing/ funding possibilities;
 - i) access conditions for students from outside of the national police;
 - j) legal conditions for participation in study courses in other countries (possibility for the transfer of credits to other training institutions);
 - k) partnerships with colleges especially those which also offer Bachelor or Master Study Courses;
 - l) delivering institution, location – city, state, country – and contacts for further information
2. collect, systematically analyse and assess the information and data given as answers to the questionnaire;
3. support national police training institutes and relevant cooperation partners in undergoing the survey by providing advice;
4. report to the Research and Science Working Group on all steps of their work.

The report, composed of the results of the survey and of conclusions shall be transmitted through the Research and Science Working Group to the 15th meeting of the Training and Research Committee and subsequently to the 18th meeting of the Governing Board.

Profile of members:

Preferably the members of the working group shall bring

- knowledge of police training and education;
- knowledge of the Bologna process and of national implementations of Bologna;
- experience in designing and implementing online surveys.

Support:

The work of the sub-group shall be supported by the CEPOL Secretariat, in particular for technically compiling the online survey, distributing the questionnaire to the National Contact Points and for collecting the answers. For communication within the sub-group and with the CEPOL Secretariat CEPOL’s e-Net may be used.

Number of meetings:

The sub-group shall have no more than two ordinary meetings.

Closure:

The sub-group shall be disbanded when the Governing Board has taken note of the final report.”
