

DECISION 32/2009/GB  
OF THE GOVERNING BOARD OF THE EUROPEAN POLICE COLLEGE  
**CHANGING THE REMIT OF THE  
TRAINING AND RESEARCH COMMITTEE  
AND AMENDING DECISION 10/2007/GB**  
**OF THE GOVERNING BOARD OF THE EUROPEAN POLICE COLLEGE**

Adopted by the Governing Board  
on 9 December 2009

THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL) <sup>(1)</sup>, and in particular Article 10(10) thereof;

Having regard to Decision 6/2009/GB of the Governing Board of the European Police College establishing a sub-group “Survey on European Police Education and Bologna”; approving the appointment of three members of the External Relations Working Group; approving the appointment of the chair, the deputy chair and four members of the Working Group on Learning; disbanding the Electronic Network Working Group and the Electronic Platform Sub-group; disbanding the Project Group “Development of a Concept for Consolidating, Updating and Publishing SEPE” and amending Decision 10/2007/GB of the Governing Board of the European Police College <sup>(2)</sup>, and in particular Article 4 thereof;

Having regard to the proposal by the Training and Research Committee, submitted by Germany <sup>(3)</sup>;

Whereas:

- (1) It is for the Governing Board on the basis of Decision 10/2007/GB to amend the remits of Committees.
- (2) The tasks of the Training and Research Committee do not include CEPOL’s knowledge management, albeit part of the Training and Research Committee’s purpose and objectives.
- (3) It is therefore desirable to adopt the following decision.

HAS ADOPTED THIS DECISION:

*Article 1*

1. In Decision 10/2007/GB of the Governing Board of the European Police College establishing committees, working groups, project groups and sub-groups and laying down rules governing the creation of committees and groups <sup>(4)</sup> Annex A4 is replaced by the text in the Annex to this Decision.

**Purpose:**

**Objectives:**

The TRC shall provide the Governing Board with support, policy advice and the information necessary for the development and monitoring of strategies which will ensure the delivery of the objectives laid down in Council Decision 2005/681/JHA (1).

**Tasks:**

The task of the TRC shall, in particular

1. advice and support the work on common standards for training sessions;
2. contribute to the preparation of harmonised programmes (Common Curricula);
3. develop training for trainers;
4. disseminate best practice and research findings and develop a European approach to police science;
5. develop tools for training quality assurance;
6. facilitate relevant exchanges and secondments activities;
7. advise and support the development of e-learning modules;
8. advise on scope, organisation and development of CEPOL’s knowledge management.

**Number of meetings:**

The TRC shall have no more than four ordinary meetings per year.”
