OF THE GOVERNING BOARD OF THE EUROPEAN POLICE COLLEGE  
**ESTABLISHING THE PROJECT GROUP**  
**“EUROPEAN POLICE EXCHANGE PROGRAMME”**  
**AND AMENDING DECISION 10/2007/GB**  
**OF THE GOVERNING BOARD OF THE EUROPEAN POLICE COLLEGE**

Adopted by the Governing Board  
on 24 February 2010

THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA <sup>(1)</sup>, and in particular Articles 7(g) and 10(10) thereof;

Having regard to the opinion of the Strategy Committee <sup>(2)</sup>

Having regard to the priorities of the Stockholm Programme <sup>(3)</sup>

Having regard to the discussion in the Police Cooperation Working Group <sup>(4)</sup>

Whereas:

- (1) There are currently developments and circumstances in this field in Europe that need a quick and comprehensive response and preparation by CEPOL for this new challenge;
- (2) The scale of this new project and the estimated impact for European police cooperation and the cooperation within the CEPOL network have to be taken very seriously;
- (3) Beside the fact that CEPOL highly appreciates the new challenge this initiative should underline the willingness and the readiness of the CEPOL network concerning this project;
- (4) It is therefore desirable to adopt the following decision.

HAS ADOPTED THIS DECISION:

*Article 1*

Decision 10/2007/GB of the Governing Board of the European Police College establishing Committees, Working Groups, Project Groups and Sub-groups and laying down rules governing the creation of Committees and Groups <sup>(5)</sup> is amended as follows

- (1) Annex 1 to this document shall replace Annex 1 to the Decision.
- (2) Annex A1.C1 is added as detailed in Annex 2 to the Decision.
