THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL) <sup>(1)</sup>, and in particular Articles 7(b) and 10(10) thereof;

Having regard to Decision 10/2007/GB of the Governing Board of the European Police College establishing committees, working groups, project groups and subgroups and laying down rules governing the creation of committees and groups <sup>(2)</sup>, and in particular Article 2(1) thereof;

Having regard to Decision 29/2006/GB of the Governing Board of the European Police College laying down the Common Curricula Policy <sup>(3)</sup>, and in particular No 4.3(5) thereof;

Having regard to the proposal of the Training and Research Committee, submitted by Germany <sup>(4)</sup>;

Having regard to the opinion of the Strategy Committee<sup>5</sup>

Whereas:

- (1) It is for the Governing Board on the basis of Decision 10/2007/GB of the Governing Board of the European Police College to disband Sub-groups.
- (2) Common Curricula Sub-groups will be dissolved after delivering the curriculum, the study material and the implementation concept and after the hand over to the Secretariat.
- (3) The work of all Common Curricula Sub-groups has been finalised.
- (4) It is therefore desirable to adopt the following decision.

10. Common Curriculum Sub-group “Management of Diversity”.
