**RENAMING THE**  
**COMMON CURRICULA COORDINATION WORKING GROUP**  
**INTO COMMON CURRICULA WORKING GROUP**  
**AND CHANGING ITS REMIT**  
**AND AMENDING DECISION 10/2007/GB**  
**OF THE GOVERNING BOARD OF THE EUROPEAN POLICE COLLEGE**

Adopted by the Governing Board  
on 25 May 2010

THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL) <sup>(1)</sup>, and in particular Article 10(10) thereof;

Having regard to the proposal by the Training and Research Committee, submitted by Germany <sup>(2)</sup>;

Having regard to the opinion of the Strategy Committee <sup>(3)</sup>;

Whereas:

(1) It is for the Governing Board on the basis of Decision 10/2007/GB to amend the remits of the Working Groups.

(2) The work on the Common Curricula has entered into a new phase requiring a different kind of support than hitherto given by the Common Curricula Coordination Group. This work would also benefit from a Working Group with experts on a more continuous basis.

(3) The members of the Common Curricula Coordination Working Group have finalised their work or are accountable to the Secretariat on the basis of contracts with their employers.

(4) It is therefore desirable to adopt the following decision.

HAS ADOPTED THIS DECISION:

*Article 1*

Decision 10/2007/GB of the Governing Board of the European Police College establishing committees, working groups, project groups and sub-groups and laying down rules governing the creation of committees and groups <sup>(4)</sup> is amended as follows:

**Purpose:**

The CCWG shall continuously ensure a high common standard of the Common Curricula and promote the implementation in the Member States.

**Objectives:**

Coordinate, support and give advice regarding the development, updating and implementation of the Common Curricula

**Tasks**

The CCWG shall in particular

1. Coordinate a concerted development and update of the Common Curricula in accordance with common quality standards
2. Facilitate and support the implementation within the network
3. Take into account the suggestions and requirements brought forward by the NCCCs
4. Develop a Manual on Development and Implementation of Common Curricula
5. Bring forward and prepare decisions concerning the development, updating and implementation of the Common Curricula
6. Review national implementation

**Number of meetings:**

The CCWG shall have no more than three ordinary meetings per year.
