**COMMITTEES AND GROUPS**

THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA of 20 September 2005 establishing the European Police College (CEPOL) <sup>(1)</sup>, and in particular Article 10(10) thereof;

THE GOVERNING BOARD,

Having regard to Council Decision 2005/681/JHA <sup>(2)</sup>, and in particular Article 10(10) thereof;

Having regard to the proposal of the Training and Research Committee, submitted by Germany <sup>3</sup>

Having regard to the opinion of the Strategy Committee <sup>(4)</sup>;

Whereas:

- (1) The establishment and the rules governing the creation and functioning of Committees, Working Groups, Project Groups and Sub Groups were laid down by Decision 19/2006/GB of the Governing Board of the European Police College <sup>(5)</sup>.
- (2) The procedure for re-nomination of existing Working Group members should be organised in a more efficient way before the call for nominations is sent out in order to base this call on the real number of vacancies for new entries.
- (3) It is therefore desirable to amend art. 4.6 of Decision 10/2007/GB of the Governing Board of the European Police College.

HAS ADOPTED THIS DECISION:

*Article 1*  
*Amendments*

Decision 10/2007/GB of the Governing Board of the European Police College establishing Committees, Working Groups, Project Groups and Sub-groups and laying down rules governing the creation of Committees and Groups <sup>(6)</sup> is amended as follows:

1. Article 6(5) is amended as follows:

“Chairs, deputy chairs and members shall serve for a period of three years; re-nominations are possible for a total period which shall not exceed six years. Six months before the end of term, but at the latest before the call for nominations of new members is launched, the member must confirm to the WG Chair about ongoing national support.”

This decision shall enter into force on 1 June 2010.
